Health, Beautification, & Welfare: It was noted that the flower boxes looked nice with the new coat of paint and fresh flowers in time for the festival and how good the new spotlights look for the sign on Kathleen look. The Board also commented on how nice Veterans Park looks after the work Bellas Landscaping did.
9. Community Development: Fall clean-up day is scheduled for September 13th. We will not be accepting tires.
10. Police: The Chief says he will work with Sarah on a scooter safety day for the kids.

They are also working to bring back the Intern Police Academy with the Seniors, a Facebook live, and a Cyber saft talk. They will keep us posted on the details.
