ORDINANCE NO. 01-23

AN ORDINANCE AMENDING THE VILLAGE OF STANFORD MUNICIPAL CODE, SAID MUNICIPAL CODE BEING ORDINANCE NO. 06-03 OF THE VILLAGE OF STANFORD, TO PROVIDE AMENDMENTS RELATING TO WATER RATES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STANFORD:

SECTION ONE: Section 50.05 (I) (1) is deleted from the Village of Code and the following provisions are substituted in place thereof:

Section 50.05 (I) (1) Charges – The following charges shall be made for water, metered or estimated:

- (1) \$24.661 per 0-1,500 gallons per billing cycle provided that the minimum charge per billing cycle shall be \$15.
- \$ 6.534 per 1,000 gallons or portions thereof for gallons between 1,501 and 20,000
- \$ 8.703 per 1,000 gallons or portions thereof for gallons between 20,001 and 50,000
- \$ 9.373 per 1,000 gallons or portions thereof for gallons between 50,001 and 100,000
- \$13.390 per 1,000 gallons or portions thereof for gallons over 100,000

All foregoing charges shall apply to properties within the Village limits. The charge for properties outside the corporate limits shall be two times the foregoing charges.


SECTION TWO: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION THREE: This Ordinance shall take effect on the first regular billing date that is 10 days after publication thereof as provided by law.

SECTION FOUR: Ordinance No. 06-03 of the Village of Stanford, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 06-03 shall remain in force and effect except as modified by this Ordinance.




