

ORDINANCE NO. 12-23

AN ORDINANCE AMENDING THE VILLAGE OF STANFORD MUNICIPAL CODE, SAID  
MUNICIPAL CODE BEING ORDINANCE NO. 06-03 OF THE VILLAGE OF STANFORD,  
TO PROVIDE AMENDMENTS REGARDING  
SOLID WASTE REMOVAL AND DISPOSAL SERVICES.

WHEREAS, the Village of Stanford, McLean County, Illinois, (the "Village") is a duly organized and existing Village under the provisions of the laws of the State of Illinois and is now operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto with full powers to enact ordinances for the benefit of the residents of the Village; and

WHEREAS, the corporate authorities, for the Village have determined that it is advisable to, necessary and in the best interest of the Village and its residents to establish a Solid Waste Removal and Disposal Service for the Village, and to require participation by Village residents and to assess the expense of that service upon Village residents together with periodic billing for water services;

NOW, THEREFORE, be it ordained by the corporate authorities of the Village of Stanford as follows:

SECTION ONE: The Village President and Village Trustees hereby find that all of the recitals herein before stated as contained in the preambles to this Ordinance are full, true, and correct and hereby, by reference, incorporate and make them part of this Ordinance.

SECTION TWO: CHAPTER 94 of the Village of Code of the Village of Stanford is hereby amended by adding the following additional provisions:

**SECTION 94.08 Solid Waste Removal and Disposal Service.**

A Solid Waste Removal and Disposal Service ("Waste Removal Service") is hereby created for the Village. The Waste Removal Service shall be the only waste removal and collection service authorized and qualified to provide such services for residential properties within the Village and shall at all times do so in a manner consistent with State law and Village ordinances. No exclusive franchise is hereby established for non-residential properties within the Village. Residential properties are hereby defined to include all single family and multi-family properties within the Village which are occupied for residential purposes, regardless of the zoning classification of the property.

**SECTION 94.09 Service Provider for Waste Removal.**

The Waste Removal Service shall be provided by a contractor selected by the Village, and an agreement shall be entered by the Village and service provider from time to time. The service provider shall be and remain fully authorized and qualified to provide such services and shall at all times do so in a manner consistent with Illinois law and Village ordinances.

## SECTION 94.10 Administration for Waste Removal.

The Waste Removal Service shall be administered by and through the Village Clerk pursuant to the existing agreement between the Village and the service provider.

## SECTION 94.11 Collection of Expense for Waste Removal.

The Village Clerk shall collect the expense of the Waste Removal Service from the residential water customers for properties within the village limits by adding, to the then current charge for such service, an administrative fee approved by the Village Board, to each residential unit's existing monthly billings for water services. This fee shall be collected in a like manner to charges for water services. All provisions applicable to the collection of charges for water services shall be applicable to the collection of charges for garbage services, including but not limited to the imposition of late fees and penalties and the discontinuation of service for non-payment. Payments received from customers for waste removal, water service and other charges collected with water service billing, shall first be applied to outstanding waste removal charges.

SECTION THREE: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION FOUR: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION FIVE: Except as provided for herein, the Village Code of the Village of Stanford, as amended by this Ordinance, shall remain in full force and effect and any other previous amendments to the Village Code shall remain in force and effect except as modified by this Ordinance.
